**RECOMMENDED TOOLS:** Hack saw, pipe joint sealant, screwdriver, level, 12" adjustable wrench, 10" pipe wrench, 5/64" hex key wrench, 9/16", 1/2", 7/16" socket wrench or open end wrench.

**LOCATION OF UNIT:** The Model 3380FR Drinking Fountain is a wheelchair accessible drinking water facility. The height dimensions shown, meet current ADA requirements. When installing this unit, local, state or federal codes should be adhered to. If height other than shown is required, then dimensions must be adjusted accordingly.

**SUPPLY LINE:** The minimum recommended line size is 1/2"IPS. Flowing pressure is 30-90 psi (2-6 ATM) for Models 3380FR and 3380GFR. Where sediment or mineral content is a problem, an inlet filter is recommended.

PLUMBING CONNECTIONS: Supply inlet is 1/2" IPS male. Waste outlet is 1-1/2"O.D. tailpiece.



TROUBLESHOOTING 3380FR/3380GFR with 6518FR			
	PROBLEM		REPAIR CHECKLIST
1.	Insufficient bubbler flow.	a.	Check that inlet screwdriver stop valve is wide open (customer supplied).
		b.	Verify minimum 30 psi flowing supply pressure.
		C.	Adjust valve to increase flow. See 6518FR manual.
		d.	Clean screens (inside nozzle body). Unscrew nozzle insert and very gently activate water supply to pop out qty. 3 screens (be careful not to lose screens). Remove any debris clogging the screen openings and place back into nozzle body. Reassemble nozzle insert.

## **General Notes:**

Before tightening nut and ferrule assembly, push tubing into fitting until it bottoms out to ensure correct engagement with O-Ring.
