BACKGROUND

A major independent services firm responsible for operating and maintaining over 170 power generation facilities in North America is committed to incorporating a strong safety culture throughout their operations. In a highly competitive and regulated market, their mission is to provide best-in-class operations to improve performance and reduce risk for their clients. The company's strong safety culture has helped them achieve an impressive recordable injury rate that is less than half of the industry average.

THE CHALLENGE

The sites they manage typically have 8-15 emergency showers onsite to provide immediate first aid in the event of an incident. Like many organizations, the equipment, although critical in an emergency, was seldom used and as a result, was often out-of-sight and out-of-mind. Their challenge was to ensure they were meeting ANSI/ISEA Z358.1 requirements with properly working equipment despite limited knowledge of the standard.

SOLUTION

Working closely with *Haws*, the company implemented a robust emergency shower and eyewash survey program and where needed, enlisted *Haws Services* to help with their annual inspections and ongoing maintenance. They also launched an educational program which resulted in heightened awareness of potential risks and became the impetus for the rollout of the survey program as a tool to help site managers understand their emergency shower and eyewash equipment readiness. Outsourcing the required annual ANSI inspections and maintenance of their emergency equipment to the *Haws Services* subject matter experts (SMEs) has been instrumental for them to achieve improved compliance results.

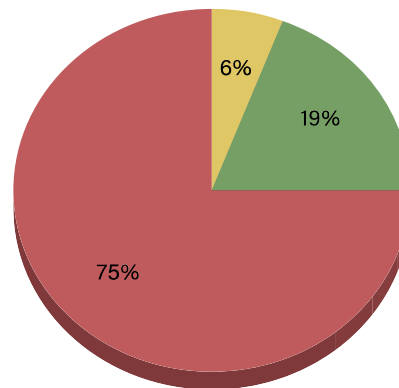

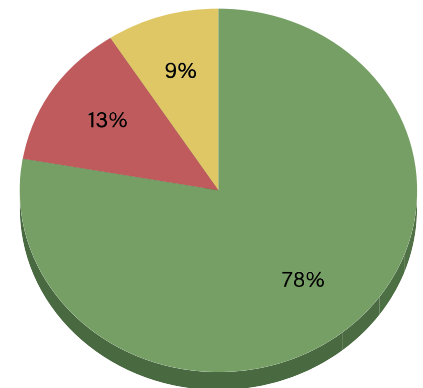
